The Institutions shall adhere to the fulfillment of the provisions of the NCTE Regulations, 2014 and ensure the following before commencement of the session; -

(i) The institution shall comply with various other norms and standards prescribed in the NCTE regulations, as amended from time to time.

The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.

(iii) The institution shall comply with the condition as laid down in the clause 8(3) of the NCTE Regulations, 2014 which provided that "An institution which has been recognized by the Council shall obtain accreditation from an accrediting agency approved by Council within five years of such recognition."

(iv) The institution shall ensure that the required number of academic staff for conducting the course is always in

(iii) The NOC of the affiliating body and staff approval thereof submitted by the institution, if found fake at any stage, the recognition, granted will be treated as withdrawn and the sale responsibility of the same will be of

the institution.

The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each neademic year the statement of annual accounts duly audited by a Chartered Accountant.

Information for having fulfilled the norms & standard and other required conditions.

In case if the land is in the name of the Society/trust, the land is to be transferred within six months in the name of the institution, failing which action shall be initiated to withdraw the recognition. It shall be essential on the part of the institution concerned to get the needful done in this regard and intimate about the same to the respective Regional Committee along with the new land documents within the stipulated time.

If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as under the provisions of Section 17(1) of the NCTE Act.

The Educational Institution shall follow Uniform Accounting System as brought out by ICA1 and accepted by MI.

The Institution shall fill the GIS Application within one month of issue of this order.

Further, if the institution is not satisfied with the order, it may prefer an appeal under sections 18 of NCTE Act, 1993 in the "online mode" available on NCTE's website www.ncte-indin.org within 60 days from the date of this order. The guidelines for filing appeal may be seen on NCTE's website.
